#### PETROLEUM HOSPITALITY AGREEMENT AT NDOLA FUEL TERMINAL BETWEEN TAZAMA PETROLEUM PRODUCTS LIMITED AND SIWI ENERGY LIMITED

This Petroleum Hospitality Agreement between TAZAMA PETROLEUM PRODUCTS LIMITED of Stand No. 415a, Mafuta Road, Bwana Mkubwa, P O Box 71651, NDOLA, Hereafter called "Landlord" and SIWI ENERGY LIMITED of Stand No. 20434 Suite No.1, Nangwenya Close, Off Nangwenya Road, Longacres, LUSAKA, Hereafter called "Tenant" is made this 14<sup>th</sup> Day of November, 2024.

The Landlord Hereby Agrees to provide Petroleum Hospitality to the Tenant of 2000m³ of a combination of Diesel and Petrol storage Space, subject to availability of ullage or space at Ndola Fuel Terminal; complete with its auxiliary equipment located in NDOLA, Copperbelt Province of Zambia for Petroleum Storage Use for a period of One (1) Year.

The Landlord and The Tenant Agree to the following Terms and Conditions for Hospitality:

- a) A fixed capacity storage fee of US\$5 per cubic meter (M³) of stock balance at the end of the month.
- b) Loss of 0.3% and 0.5% on the Diesel and Petrol respectively shall be applied at the point of receiving and on book balance at the beginning of every month.
- c) Offloading charge of US\$5 per cubic meter shall be paid by the Tenant.
- d) Throughput charge of K62.64 per cubic meter shall be paid by the Tenant.
- e) The fuel shall be sampled and analysed at an independent laboratory at the Tenant's cost prior to offloading into the Landlord storage tanks.


